

## RESOLUTION TO AMEND DECLARATION

### WATERFORD CROSSING COMMUNITY ASSOCIATION

WHEREAS Waterford Crossing is a planned community that was created by the recording of a Declaration of Covenants, Conditions and Restrictions, later amended by the Unit Owners of the Association; and

WHEREAS Waterford Crossing is a private residential community, consisting of 42 dwellings, and

WHEREAS, the Unit Owners of Waterford Crossing wish to preserve the quiet residential character of their community, free from the rancor and discomfort of public debate of political issues and from commercial signage  
NOW, THEREFORE, the Unit Owners of Waterford Crossing hereby resolve to amend the Amended Declaration of Covenants, Conditions and Restrictions as follows

1. Section 15(f) of the Amended Declaration of Covenants, Conditions and Restrictions shall be amended to read as follows:

No signs of any kind, whether commercial, political or personal, may be placed or displayed on any Lot or Dwelling or on the Common Facilities. Notwithstanding the foregoing prohibitions, small "For Sale" signs may be displayed in a window of a Unit and small security company identification signs may be placed on the Common Facilities outside a Unit. The Board of Directors is authorized to adopt and implement reasonable rules and regulations governing such permitted signs.

2. Section 16(d) of the Amended Declaration of Covenants, Conditions and Restrictions shall be deleted.
