WHEREAS, the Association was formed and exists, in part by the recording of the Master Deed on May 24, 1988 in the Atlantic County Clerk's Office in Deed Book 4686, Page 136, et seq.; and

WHEREAS, the amendment presented to the membership for consideration required the membership to vote in favor to approve an amendment to the Master Deed; and

WHEREAS, the Master Deed require 2/3's of the eligible votes in favor of amending the Master Deed once presented to the membership for a vote; and;

WHEREAS, more than 2/3's of the eligible members voted in favor of the amendment;

WHEREAS, the amendment to the Master Deed shall be deemed valid and adopted;

NOW, THEREFORE, the Association does hereby amend, modify and supplement Section 11(R)(i) the Master Deed by replacing it as follows:

A. Section 11(R)(i) Restrictions

Unit Owners must reside in the Unit for 2 years before it is eligible to be leased. The Board shall be authorized, by resolution, to establish a process and procedure for leasing eligibility and to amend same based on market and environmental conditions.

- B. The remainder of the Master Deed shall remain unchanged.
- C. Notwithstanding the full execution of this amendment, this amendment shall not take effect until the recording of same in the Atlantic County Clerk's Office.
