The Ordinance allows solicitation of political, electoral, religious, community, charitable or other public interest groups or individuals as exempt. (141-8). Section 141-7 only allows solicitation of exempt organizations between the hours of 9 AM and 5 PM (Monday thru Saturday only). Police should be called if these ordinances are violated (609 652 3705 Option 1).
